HIGHLAND COUNCIL REPRESENTATION ON DOUNREAY STAKEHOLDER GROUP

I am writing to you to ask whether you can bring up the question of Highland Council representation on the Dounreay Stakeholder Group.

At present we have representation from Councillor David Flear (landward), Councillor George Farlow (North Sutherland) and Councillor Donnie Munro (Thurso). Katrina MacNab represented Wick until her resignation earlier this year.

The DSG feels it is important to ensure that all areas of Caithness and North Sutherland are well represented by Highland Councillors and ask if you could raise this at your business meeting with a view to identifying a replacement for Katrina.

We would also like to raise the importance of attendance at these meetings – the Dounreay decommissioning programme is progressing well and the programme may well further accelerate when the new parent body organisation takes over in April 2012. Therefore it is important that we maximise the benefit of the Dounreay site operations now while we still have an opportunity to do so.

We are somewhat disappointed at the regularity of attendance of Councillor Donnie Mackay and ask that you remind Councillors that deputy arrangements should be put in place in times of absences from those nominated to represent the Highland Council on this group.

We are aware that following the Council elections next May the representation on DSG may change completely but until then we believe it is extremely important that all areas of Caithness and North Sutherland continue to be involved in DSG.
