CONSULTATION QUESTIONS

Question 1 Do you agree that a waste substitution policy should be adopted for radioactive waste arising from overseas research reactor fuel reprocessing contracts at Dounreay?

Favour return of cemented MTR <u>and</u> PFR wastes to country of origin, or radiological activity equivalent of substituted MTR wastes, resulting in a net decrease of the waste inventory at Dounreay, as would have been expected when the agreements were entered into.

IN PART

The constitutional status of UK suggests that the specific measures described in this consultation are finite, and in accordance with the principles of minimum transport of waste. However broad environmental neutrality for the UK is a principle that goes way beyond this, and one which we cannot accept. Consideration should be given to national responsibilities and return of waste within the UK, and environmental neutrality of constituent countries, in conjunction with principles of minimum transport and storing waste 'near' where it was produced. Accepting broad environmental neutrality for the UK could in the future permit Dounreay to be used as the national waste store.

Question 5 Do you agree that all of the relevant implications of the proposed policy have been identified?

NO

It is not known how receiving countries will react to the returning of their, or substituted waste. Other factors may have to be taken into account. Based on the principle of minimising the transport of radioactive waste, and this waste being a small proportion of the total waste held at Dounreay, is it best to leave waste where it is? The cost of treatment and storage to be borne by the originating country.

Cross border issues are not addressed such as long term responsibility for waste substituted, and 'internal' environmental neutrality.
