REPORT FROM CAITHNESS PARTNERSHIP

International Association of Transport Professionals Conference 27 – 29 September 2011

The conference considered in turn each mode of transport taking into account international connectivity as well as domestic. Several of the guest speakers noted that the UK's transport connectivity is ranked 26th in the world, which is poor in relation to their overall GDP ranking of 10th in the world. Scotland in particular requires increased external connectivity.

It was recognised by MPs and MSPs present that capital investment in the transport infrastructure is required as it is an essential driver to stimulate economic growth, and long term growth. However, during the remaining 3 years of the Strategic Transport Project Review (STPR) capital funding is limited for the Highlands. Only 3 of the 29 STPR projects are based in the Highlands, with the central belt claiming much of the funds for their major improvement programme including the Forth Road Bridge. All capital used to improve the transport infrastructure must represent good value for money.

It was noted that there is a need to "unlock development" within the local infrastructure and Cllr David Flear ensured that the 'pinch point' Berriedale Braes was aired during several of the sessions, with the low cost improvement proposal, indicating good value for money. Sam McNaughton, Head of Transport (THC) stressed the need for moving projects to a 'shovel ready' stage, and included Berriedale Braes and widening of the A99 north and south of Keiss in the imminent improvement projects required within the Highlands

CO2 emissions & logistics were discussed at length and all sectors appear to be making progress towards reduction in emissions.

One of the main points taken forward from the IATP conference is that there is no joined up policy for Scotland's transport. Each sector have their own policy but an overarching strategy outlining short, medium and long term plans is missing. The production of such a document would maximise collaboration between all four transport sectors and exploit the connectivity potential for Scotland at an international and domestic level.
