3. MINUTES OF THE LAST MEETING

The minutes of the last AGM held on 7th March 2012 were accepted as a true record. This was proposed by Alastair MacDonald and seconded by Eann Sinclair

4. CHAIRMAN'S REPORT

DSG(2013)C007 refers. Bob Earnshaw noted that it had, again, been a busy year and thanked members for their contribution throughout the year.

He noted he would take the report as read unless anyone had any questions. On a personal note, Bob said he had enjoyed his time as Chairman of DSG. He had come to Caithness in 1977 and this was his way of putting something back into the community.

7. DSG FORWARD DIARY

8. WEBSITE REPORT

DSG(2013)C011 refers. Alan Scott noted the high numbers of '.com' visitors. He asked if anyone knew what this related to. The Secretary responded that visitors to the site with a '.com' tag referred to commercial companies.

9. **TERMS OF REFERENCE**

The Terms of Reference were tabled. Bob Earnshaw noted no changes had been made to the Terms of Reference but suggested that members read these to refresh their understanding of the roles of members and deputies.

Before he handed over the Secretary for the nomination of office bearers he noted that David Flear (current Vice-chair of DSG) had stepped down from Highland Council during his term as Vice-chair of DSG. The Terms of Reference allow for continuity of chair and vice-chair and therefore David's representation at DSG had remained.

DSG, via the external review, had recognised that, and in accordance with the Terms of Reference, that there was capacity to expand member with up to five places for members of the public. As David had worked tirelessly for DSG in the past and because of his knowledge and contacts Bob Earnshaw proposed that David Flear be co-opted on to DSG as a member of the public. Roy Kirk seconded the proposal. Hence David Flear was officially co-opted to DSG as a member of the public.

At this point in the proceedings the DSG Chairman stepped down and handed over the chair to the Secretary.

10. ELECTION OF OFFICE BEARERS

June Love noted that there had been no written nominations for office bearers. However, she was aware of verbal nominations coming forward and had taken the liberty to check with those not present whether they would be willing to take on a role if nominated.

John Deighan nominated Anne Chard. This was seconded by Gordon Jenkins. [NB: Anne Chard had been unable to attend meeting, however she had indicated her willingness to take on an office bearers role if nominated).

Socio-Economic sub group chairman:

Eann Sinclair nominated Derrick Milnes. This was seconded by Thelma MacKenzie. [NB: Derrick Milnes had been unable to attend meeting, however he had indicated his willingness to continue in socio economic sub group chair role if nominated).

Site Restoration sub group chairman:

Alan Scott nominated Bob Earnshaw. This was seconded by Roger Saxon. Bob Earnshaw attended this meeting and accepted this post.

June Love noted that deputies chairs for the sub groups would be considered at the next sub group meetings. She also noted that Bob Earnshaw would remain as Acting Chairman for the evening meeting. She then handed proceedings back to Bob Earnshaw.
