

DSG CHAIRMAN'S REPORT 2018/19

This year sees my second year as DSG Chairman come to an end. I would like to take this opportunity of thanking everyone involved with DSG for their input, commitment and open and honest discussions that have taken place throughout the year.

Again I would like to stress that DSG is not just about four public meetings per year with a number of sub groups meeting. There is a huge contribution from many DSG members in between meetings to ensure we respond timeously to consultations, we pick up issues and continue to progress these throughout, provide responses to press comments and generally try to get on top of a massive agenda for the local community– from the site's decommissioning activities, to safety and environment, the neighbouring Vulcan site and to the future of the area when the decommissioning is complete. Not only that, but as a DSG we are represented on a number of other local groups which is outlined below.

This year has seen us starting to think about the focus of DSG going forward into financial year 201 /20. As decommissioning progress it will be equally important to ensure the DSG continues to oversee and scrutinise the safety and environmental aspects of both Dounreay and Vulcan site alongside progress of decommissioning activities allied to value for the taxpayer.

In addition, DSG continues to support socio economics which are aligned to CNSRP priority projects to allow us to get behind those projects that require substantial funding which will support the creation of jobs in the area.

As I reflect over another busy year, the focus for 2019/20 for DSG will be:

 - strategy for its' nuclear sites, in context of impact of Dounreay target cost contract.
 - Socio economic funding requests over next 4-5 years.
- **Cavendish Dounreay Partnership/Dounreay Site Restoration Ltd**
 - Value for money of CDP contract
 - Key milestones for delivering decommissioning programme
 - Resource planning for decommissioning programme
 - Supply chain activity including socio economic benefits
 - CDP engineering hub project
 - Dounreay recruitment/supply chain
- **Vulcan**
 - Future site options
 - Decommissioning programme
 - Socio economic activities from decommissioning.
