

VULCAN NAVAL REACTOR TEST ESTABLISHMENT**DNSR QUARTERLY REPORT****1 Jan 2020 to 31 Mar 2020****FOREWORD**

This report is issued as part of the Defence Nuclear Safety Regulator's (DNSR's) commitment to make information about inspection and regulatory activities relating to the Defence Nuclear Programme¹ available to the workforce and the public. The Secretary of State for Defence is answerable to Parliament for the safety of all defence activities; he has issued a Health, Safety and Environmental Protection Policy Statement requiring the Ministry of Defence (MoD) to comply with legislation, and where there are exemptions relating to defence activities, to make, so far as is practicable, arrangements at least as good as those required by legislation. DNSR is empowered to regulate nuclear and radiological safety in the Defence Nuclear Programme. This is achieved in a manner that complements and joins up with the work of statutory regulators².

Vulcan Naval Reactor Test Establishment (NRTE) is an Authorised Site under MoD regulation; Authorisation is a process akin to licensing under the Nuclear Installations Act. Statutory regulators have roles under general health, safety and environmental legislation, and DNSR Inspectors work closely with them; this report should be read in conjunction with theirs. The report is made available to members of the Dounreay Stakeholder Group. Where possible, a DNSR Inspector will attend Stakeholder Group meetings and will respond to any questions raised. Additionally, DNSR Inspectors may be contacted at their offices at Abbey Wood, Bristol.

PERIOD OF THIS REPORT

1. This report covers the quarterly reporting period from 1 Jan 2020 to 31 Mar 2020.

ROUTINE MATTERS

2. Routine visits to the site are made for the purpose of undertaking pre-planned examinations of the adequacy of safety management, examinations of Authorisation Condition (AC) compliance or compliance with other regulations or attending formal meetings with site management or their representatives.
3. During this period, 1 Routine visit was made to Vulcan NRTE by DNSR:
 - a. **28 & 29 Jan 20** - Planned System Based Inspection;
 - b. **4 Feb 20** - Lonestar 20 Level 1 Exercise Planning meeting;
 - c. **11 Mar 20** - Level 3 Regulatory Interface Fora meeting;
 - d. **12 Mar 20** - Facility Safety Case presentation.

4. DNSR has not placed any regulatory enforcement actions on the Naval Superintendent Vulcan in this quarter.
