
Introduction



Website hits, have remained relatively stable throughout February 2021 – January 2022, with the highest website hits recorded in the May 2021, June 2021, and July 2021.



Website visitors


The chart below summarises the number of visitors to the website throughout (February 2021 to Jan 2022).
