FOREWORD

This report is issued as part of the Defence Nuclear Safety Regulator's (DNSR's) commitment to make information about inspection and regulatory activities relating to the Defence Nuclear Enterprise¹ available to the workforce and the public. The Secretary of State for Defence is answerable to Parliament for the safety of all defence activities; he has issued a Health, Safety and Environmental Protection Policy Statement requiring the Ministry of Defence (MoD) to comply with legislation, and where there are exemptions relating to defence activities, to make, so far as is practicable, arrangements at least as good as those required by legislation. DNSR is empowered to regulate nuclear and radiological safety in the Defence Nuclear Enterprise. This is achieved in a manner that complements and joins up with the work of statutory regulators².

Vulcan Naval Reactor Test Establishment (NRTE) is an Authorised Site under MoD regulation; Authorisation is a process akin to licensing under the Nuclear Installations Act. Statutory regulators have roles under general health, safety and environmental legislation, and DNSR Inspectors work closely with them; this report should be read in conjunction with theirs. The report is made available to members of the Dounreay Stakeholder Group. Where possible, a DNSR Inspector will attend Stakeholder Group meetings and will respond to any questions raised. Additionally, DNSR Inspectors may be contacted at their offices at Abbey Wood, Bristol.

PERIOD OF THIS REPORT

1. This report covers the quarterly reporting period from 1 Aril 2022 to 30 June 2022.

ROUTINE MATTERS

- 2. Routine visits to the Site are made for the purpose of undertaking pre-planned examinations of the adequacy of safety management, examinations of Authorisation Condition (AC) compliance or compliance with other regulations or attending formal meetings with Site management or their representatives.
- 3. During this period, two routine visits were made to Vulcan NRTE by DNSR. Regular and planned MoD NET Skype and MS Teams meetings with Naval Superintendent Vulcan (NSV) continue.
 - **a. 7 Jun 22** Walk down of the DSMP1 and Shore Test Facility. Discussions held on the appointment of the new Rolls Royce Chief Engineer including the Vulcan Site Safety Committee terms of reference and methods of working. Attendance at the Vulcan Safety Case workshop;
 - **b. 8 Jun 22** Themed intervention focused on reviewing the management arrangements under AC15 (Periodic Review) that the Authorisee periodically stands back and reviews the Safety Case for the Vulcan NRTE Site.
